Notice on School Infectious Diseases

Your child has currently contracted a school infectious disease, and is being asked to stay home from school for the length of time indicated below. When they attend school (kindergarten) once again, we ask that you please submit the School Infectious Disease Attendance Contact Form found below to their teacher (after first filling in every field).

Notice

1. Major school infectious diseases and the lengths of time to stay home

Regarding the following the School Infectious Diseases.

- 1) Influenza... No less than five days after contracting the illness, with the actual date it was contracted taken as day zero, and no less than two days after their fever has broken (three days for infants).
- 2) Pertussis... Not before the cough characteristic to this illness has cleared up or until they have completed a five-day treatment regimen via a suitable antibiotic preparation
- 3) Measles... No less than three days after their fever has broken.
- No less than five days after swelling of the parotid gland, submandibular 4) Mumps... gland, or sublingual gland has occurred, and not before their overall condition has improved.
- 5) Rubella (3-day measles)... Not until all of their rashes have disappeared.
- 6) Chicken pox (varicella)... Not until all of their rashes have scabbed over.
- 7) Pharyngoconjunctival fever (PCF)... No less than two days after all of their major symptoms have cleared up.

*If your physician determines that there is no risk of infection even during the period listed above, please submit a doctor's certificate to indicate such.

2. Other school infectious diseases and the length of time to stay home (requires a doctor's certificate or other proof)

- 1) Tuberculosis
- 2) Meningococcal meningitis
- 3) E. coli 4) Pink eve

- Until a doctor has determined that there is no risk of infection
- 5) Acute hemorrhagic conjunctivitis

3. Suspension of Attendance Relating to the Novel Coronavirus

- 1) Novel Coronavirus (infected person)... until the health center or a doctor confirms that there is no risk of infection.
- 2) Novel Coronavirus (close contact)... until the end of the quarantine period as specified by the health center. However, there must be no symptoms associated with the novel coronavirus (fever, cough, taste or smell disorder, etc.)
- *A doctor's certificate is not required for suspension of attendance due to the novel coronavirus.
